We will only use the information:

- To communicate with members about any aspect of the Dore Village Society and its activities.
- To send birthday cards.

We will not share any data with any third party unless there is a legal requirement to do so.

Members have the right to a copy of the data we hold about them and we will rectify any errors we become aware of. Members also have the right to have their data deleted and we must comply with any such request within a reasonable timescale.
